Executive Summary

This report has been generated automatically using the data provided by the Florida Secretary of State's office from August 12, 2025 to September 09, 2025.

Special Projects

This section contains unique information for special projects. It will vary from month to month as topics of interest change.

This month adds two new sections to the report: "Elections" that will contain content when an election has occurred in the last 60 days and any non-compliances with the book closing date have been identified. And "New Registrations" that will report on the number of new registrations by party for your county.

Flections

This section contains unique information for recent elections if any.

Florida Statute § 104.15 makes it illegal for an unqualified elector to willfully vote in an election. The statute states: "Whoever, knowing he or she is not a qualified elector, willfully votes at any election is guilty of a felony of the third degree, punishable as provided in s. 775.082, s. 775.083, or s. 775.084."

In Florida, a "qualified elector" under § 97.041 is a U.S. citizen, at least 18 years old, a Florida resident, and registered to vote in their county of residence by the book closing date—29 days before an election, per § 97.055. Only willful voting with knowledge of ineligibility is penalized, not honest mistakes, with penalties up to 5 years in prison and a \$5,000 fine. If a book closing falls on a holiday or Sunday, an additional day is accounted for when assessing compliance in the table.

As of this writing there are 7,927 total registered voters in Union County.

Electorate Changes

Voter Numbers

There are **30** new voters this month in Union County. During this same time, **21** voters have been removed from the county's registrations.

Florida allows a person who is otherwise qualified to preregister on or after that person's 16th birthday and may vote in any election occurring on or after that person's 18th birthday. See FS 97.041 5(b) for details.

There are 27 pre-registered (underage) voters in the county's registrations for this month.

Voter Migration

Voters move for a variety of reasons. This month Union County experienced **55** voters that had their address changed within the system.

21 voters have either moved out or have been removed for Union County while 30 have moved in. The remainder, 4 had a change in either their residential or mailing address which may warrant an inquiry to your Supervisor of Elections to learn more.

Voter Status Changes

Voter Activity

A voter changes their status because of "Voter activity" or "Voter inactivity".

"Active voter" refers to a registered voter whose registration status is active.

"Inactive voter" refers to a registered voter whose registration record has been placed on inactive status after procedures in section 98.065(4)(c), F.S., and Rule 1S-2.041 were followed.

Per Rule 1S-2.041(3)(e) a voter placed on inactive status cannot become active when a third-party address change has been received. An inactive voter can only be restored to active status upon the voter's own activity as set forth in section 98.065(4)(c), F.S.

Removal from the rolls. If an inactive voter does not sign a petition, vote, request a vote-by-mail ballot or update his or her voter registration record by the second federal general election after the date he or she was placed on inactive status, the Supervisor shall remove the name of the inactive voter from the FVRS no later than December 31 in the same year of the second federal general election. Except as provided in subsection (5), no address list maintenance notices can be issued and a voter's name cannot be removed during the 90-day period immediately preceding an election for federal office.

1 voters had their status changed from INACTIVE to ACTIVE.

0 voters had their status changed from ACTIVE to INACTIVE.

Party Affiliation

Voters change parties for a variety of reasons. The following table captures the number of voters who changed their party affiliation and to which party they moved to this month.




FIGURE 1 - PARTY MOVEMENT

Anomalies

This section reports on anomalies found in the voter registrations.

Elector That Appears to Have Voted in an Election Before Being Registered This query looks for voters who show having voted prior to their date of registration.

This situation should only occur when a voter for some reason becomes ineligible and subsequently gets reregistered. When a voter re-registers they get a new voter ID yet their old voting history stays intact. This then shows up as voting prematurely.

Another possibility is a data entry error or a bug in the election management software. There were **2** voters where this happened, and this is how they casted their votes:
